

God's Word on Abortion

Does it matter? When does human life begin?

Summary: With the news of what Planned Parenthood is doing, and sonogram evidence now of human life starting in the womb at earlier and earlier stages – it's time to visit this topic. We believers must know what God's word says on this. We must not remain silent. This message covers topics like "celebrities" who were almost aborted, what God says about the value of unborn babies, will aborted fetuses/babies have a future with God?, and what if YOU have had an abortion? All this and more. Spread the word about this message.

Welcome everyone to Light on the Rock. Today I'm covering a topic from the Bible point of view – the topic of abortion. It's a hot topic lately, especially with the recent news about Planned Parenthood selling aborted baby body parts – as shown on 6 undercover videos. What are we coming to? What does God say about all this? And what about distressed young women who know they shouldn't have been careless – or sinful – and have become pregnant, and don't know what to do about it? Can we understand their worry and struggle?

I think many of you have known or have been the young woman -- who – due to fornication or adultery – finds herself pregnant, with an unwanted and unplanned pregnancy. This would be especially difficult if the young woman is not married and therefore the "father" is not her husband. Or can you imagine yourself after a sinful adulterous fling finding yourself pregnant? David and Bathsheba certainly knew that feeling. Wow, that would be tough. Sure, there is sin involved, sure there are consequences, but now what do you do?

In these cases – and if this had happened to *you* – surely we could understand that one of our early strategies, carnal as it is, could understandably be – "let's just have an abortion". I get that. I can feel that. (I'm trying to put myself in the role of the man who caused the unwanted pregnancy). In that case, yes, I think we could understand the thought of aborting this whole mess, as we would see it at that time.

But does that justify the abortion? And what is an abortion, in God's eyes?
Let's talk about all that today.

In light of the recent videos showing more horrors from "Planned Parenthood", maybe it's time to see what scripture has to say about abortion. *I fear that many believers are giving up on this topic. Some feel it's too entrenched to make any difference now. Others have said "it's not our fight".* I wrote a blog on this topic a few years ago, but would like now to give a full sermon on it.

Though the word "abortion" is never mentioned in the Bible, it has a lot to say on the topic, as you'll see.

Abortion is the ending the life of, and removing the body of a human fetus, an unborn human life, a baby boy or girl in the making. That living being is not a lizard, it's not a cat, and neither is it just "tissue". He or she is alive, and he or she is human.

As President Reagan commented on Sept 21, 1980 – “I’ve noticed that everybody who is for abortion has already been born.” I have to wonder how many great men and women we’ve missed – because they died as 4-5-6 month old unborn baby girls or boys on the abortion mill’s tables. Here are a few of the famous people who were *almost* aborted. Imagine the world without them.... Whether you like these folks or not, they all have had a significant impact on the world.

- **Celine Dion** – says her parish priest convinced her mom to not abort her. Celine was, after all, her mom’s 14th child!
- **Cher’s** mother changed her mind at the last minute at the clinic. Cher is pro-choice. Go figure.
- **The actor Jack Nicholson** is here today because his mom also decided at the last minute not to go thru with it.
- **Justin Bieber.** His mom was a victim of sexual abuse, but kept her baby, though she was advised to end the pregnancy. No, she kept her Justin Bieber.
- **Tim Tebow** the great football player – his mom had a very problem pregnancy but refused an abortion, and went on to successfully give birth to Tim Tebow.
- **Pope John Paul II** reportedly also was almost aborted.
- **Nick Cannon** – R&B singer, and host of America’s Got Talent -- actually wrote a song to his mother “Can I Live” –
 “I am a child of the King; ain’t no need to go fear me;
 And I see the flowing tears so know that you hear me
 When I move in your womb, that’s me being scary
 Cuz who knows what my future holds...
 If I could talk I’d say to you...
 ‘Can I live?’
 And later in the song --- “Thanks for giving me life. Momma, thanks for listening.”

My eyes welled with tears as I read and heard that song. Sure, it was rap and stuff -- but I hope I have your attention. All of these folks were all once considered by the Pro-Choice folks as just so much “tissue”, just a simple extraction.... No, they are real people who gifted the world with their presence and contributions – because their moms changed their minds and did not go through with the abortion.

There are many, many more. John Lennon and Yoko Ono almost aborted their **son Sean Lennon** – but thankfully, John Lennon decided they should keep their child in Yoko Ono’s womb. He’s in his 40’s today.

What about the millions of unknowns who are alive today – because their moms decided to keep them instead of throwing them into the trash or selling their body parts for cash?

In the USA alone, there have been many MILLIONS of lives snuffed out over the years – approved and legalized by our own Supreme Court in January 1973. Planned Parenthood

all by itself ends the lives of around 330,000 unborn babies each year, and that's only 40% of the total number nationwide, when you include other clinics. The total number is over 730,000 a year!

Interesting note: almost HALF the abortions in New York City are from young black women. That's way past their percentage of the population. **Margaret Sanger** - - a beloved leader of feminists and founder of Planned Parenthood - - had openly said that abortions would be a great way to keep the black population down. Her wish is happening. You can look up her Eugenic Plans yourself. They're disgusting! It's also called "the Negro Project", which she wrote in 1939.

There they document Margaret Sanger's attitude towards blacks. She said they, and immigrants: "*they are ...human weeds, reckless breeders, spawning human beings who never should have been born.*" She called them "*genetically inferior*" (Birth Control Facts and Responsibilities, 1925). She wanted to limit population growth and wrote that married couples should have to apply to have children. (Birth Control Review, April 1932). And *she* started Planned Parenthood.

Abortion doctors -- who as MD's had given an oath to protect human life -- like to refer to an unborn baby boy or girl as "tissue". They equate it to removing an inflamed appendix or a bad tooth. But it's not the same comparison at all, as we shall see. Ponder this. This false equation is been repeated over and over. Repeat a lie often enough, and people believe it.

Also, I'm sure that when someone is scared -- for example if they got pregnant due to adultery, or fornication -- and don't want the shame of everyone finding out -- yes, I can understand the temptation to abort would be very, very strong in those cases. God is their judge, not me. I can't condemn the *person* -- though I strongly speak against the *action*, the violence, done by abortion.

So though my heart can go out to certain ones in cases like that, I still think we all need to review what GOD says about it all in his word, and where God is silent about it. This is not an easy issue in very instance. I want to say that. I want you to know, I *know* that and *feel* that. This message will sound tough and lacking in compassion to some who hear it -- but that certainly is not my heart on this matter. So let's get started with the tough stuff first:

Young women have been told over and over and so they repeat the mantra: "It's MY body, it's MY choice. Nobody else's."

Yes, it's their body, but to women who say that, I ask: are you not also carrying another body, another life, protected in your womb? Should your choices not be made before a little unborn baby girl or boy comes into existence inside your womb? Has anyone asked that little girl or boy if she/he would like to be crushed out and removed from existence? This unborn child is a *SEPARATE* human life residing inside your body, ladies. It has its own heart, his or her own brain, his/her own blood -- maybe even different from the mom's blood type, the baby has his or her own DNA, his or her own life and future! She's residing in you -- in your body -- but that BABY is a separate life on her or his own!

We were told in 1973 that we didn't know when this "tissue" became a human life. Since then, however,

- very clear sonograms have let expectant mothers see their baby at 3, 4, 5, 6 months and beyond.
- We know by day 18 – day 18! -- there is a beating heart.
- So now, though the **original Roe v Wade allowed abortions in the first trimester**, now we see late-term abortions, we see the likes of **Kermit Gosnell** and his clinics of horror... if you've forgotten, Google his name and see what I mean. Kermit Gosnell was convicted of murdering 3 infants that were born alive under his care. But the horror stories go way, way beyond those three. Most of his abortions in his filthy clinic were beyond 24 weeks (6 months). He killed those unwanted babies born alive by severing their spinal cord.

So what does God -- through His Word --have to say on the topic? The Supreme Court decision "Roe v. Wade" was based on what we know now was a lie: there was no rape. "Roe" – Norma McCorvey - - now is fighting to reverse the court decision she was instrumental in creating. No, she was never raped. And her baby came to full term and was adopted out.

Today we'll try to look at it as fairly as we can. We'll discuss

- when human life begins. Is the unborn fetus or baby a human person?
- Is abortion seen as murder in the Bible?
- "what if the baby was conceived in rape or violence?"
- "What if the life of the mother is at stake if she continues the pregnancy?" In cases of rape, incest or danger to the mother's life, would abortion be justified?
- And finally, for any of you reading this who has had an abortion, now what? What's your future with God? What does GOD say? Will you be accepted by God's children?
- What will happen to all those millions of destroyed pre-borns? Will they be resurrected? I'll give my best shot at answering that.

Let's look at God's word:

GOD calls us "HUMANS" – long before we are born.

Jeremiah 1:5 tells us that God knows us before we're even born. We now know that the human DNA of the fetus is already all there from its earliest days. This verse is about Jeremiah, but the principle is clear: God knows us before we are born. After all, the DNA is set very, very early. And notice WHO it is who forms us in the womb. HE is the Creator, and HE created you and me.

Jeremiah 1:4-5

Then the word of YHVH came to me, saying:

"Before I formed you in the womb I knew you;

Before you were born I sanctified you;

I ordained you a prophet to the nations."

One of my favorite passages in the Bible is Psalm 139.

Psalm 139:13-16

"For YOU formed my inward parts;

YOU covered me in my mother's womb.

14 I will praise You, for I am fearfully and wonderfully made;

Marvelous are Your works, and that my soul knows very well.

15 My frame was not hidden from You when I was made in secret,

And skillfully wrought in the lowest parts of the earth.

16 Your eyes saw my substance, being yet unformed.

And in Your book they all were written, the *days fashioned for me,*

When as yet there were none of them."

Now this next one, Isaiah 49:1 – is a Messianic prophecy, I realize. But still, it makes the point how Yahweh is aware of us even in the womb!

Isaiah 49:1

"Listen, O coastlands, to Me, and take heed, you peoples from afar!

Yahweh has called Me from the womb;

From the matrix of My mother He has made mention of My name."

God's word refers to fetuses – as 'baby'. So do most obstetricians.

When an expectant mom goes to see her doctor about her pregnancy, the doctor refers to "your baby" in all the discussions. They normally don't call that unborn child a "fetus" – at least not to the mother. The Bible does the same.

Luke 1:41, 44 – when **Mary the mother of Yeshua (Jesus) met with Elizabeth**, who was carrying the future John the Baptist:

Luke 1:39-45

Now Mary arose in those days and went into the hill country with haste, to a city of Judah, 40 and entered the house of Zacharias and greeted Elizabeth. 41 And it happened, when Elizabeth heard the greeting of Mary, that THE BABE leaped in her womb; and Elizabeth was filled with the Holy Spirit. 42 Then she spoke out with a loud voice and said, "Blessed are you among women, and blessed is the fruit of your womb! 43 But why is this granted to me, that the mother of my Lord should come to me? 44 For indeed, **as soon as the voice of your greeting sounded in my ears, THE BABE (baby) LEAPED in my womb for joy."**

When Joseph was told about the plans for Mary to carry the Son of God, there was no discussion about "tissue" - - but a real person, even before birth.

The angel tells Joseph in a dream ...

"...for the CHILD who has been CONCEIVED in her is of the Holy Spirit. She will bear a SON, and you shall call his name Yeshua [they were Hebrews, this is the correct Hebrew name], for He will save people from their sins." (Matthew 1:20-21).

So the unborn human fetus is referred to – in Scripture – as ***the baby, the child***, and we were told God has plans for that unborn child (Psalm 139:16). This is a UNIQUE life, worthy of total protection from all of us! *Come on believers! Stand up for this truth. Speak up for this truth. Support this truth. Don't stand on the sidelines silent.*

Scripture says: The penalty for injuring or killing an unborn child in his/her mother's womb – is the same as the penalty for injuring or killing an adult.

Did you realize that? Now what does that tell us?

Exodus 21:22-23

"If men fight, and hurt a woman with child, so that she gives birth prematurely, yet no harm follows, he shall surely be punished accordingly as the woman's husband imposes on him; and he shall pay as the judges determine.

23 But if any harm follows, then you shall give life for life, eye for eye, tooth for tooth, hand for hand, foot for foot, burn for burn, wound for wound, stripe for stripe.

So if an unborn baby girl or baby boy dies because of violence, the perpetrator of that violence that caused the baby's death shall also die. In other words, the unborn child was murdered and murder is punished by execution. Can it be any clearer how seriously Almighty God sees abortion?

In Biblical days, the ancient Ammonites – and later the Israelites – often offered their babies to Molech, one of the horrific pagan gods of the area. It's not entirely clear how this was practiced, but we know scripture speaks of "passing through the fire" to Molech and we know in some cases they were killed first, and then offered as burnt offerings – but others believe live children were offered to the hot metal arms of this god before falling into the fire as a burnt offering. God despised this. Are our 1 million abortions a year any better? Are they? Or is this just another version of offering our children to Molech?

One of the first commands from God Almighty after the Flood was that if someone murders another – the murderer must be executed.

Genesis 9:6

"Whoever sheds man's blood,

By man his blood shall be shed;

For in the image of God He made man."

We can also see from this verse and the ones I've used already – putting them all together – that even an unborn baby – is made in the image of God, and Yahweh does not take it lightly at ALL when someone decides to end any human life – whether in the womb – or as an adult.

Understanding this makes the statement by Judah, upon hearing of Tamar's pregnancy – which HE unknowingly had caused – all the more appalling. In his hypocrisy, he was willing to kill his daughter-in-law by burning her alive -- along with her TWINS growing inside of her!

Genesis 38:24-26

'And it came to pass, about three months after, that Judah was told, saying, "Tamar your daughter-in-law has played the harlot; furthermore ***she is with child by*** harlotry." So Judah said, "Bring her out and let her [and the twins she was carrying] be burned!"

25 When she was brought out, she sent to her father-in-law, saying, "By the man to whom these belong, I am with child." And she said, "Please determine whose these are — the signet and cord, and staff."

26 So Judah acknowledged them and said, "She has been more righteous than I, because I did not give her to Shelah my son." And he never knew her again.'

Judah was making a judgment based on hearsay without careful diligence first. Truly later on, a daughter of a priest who gets involved in harlotry was indeed sentenced to death by burning (Leviticus 21:9), for profaning the office of her father. But Tamar was not a harlot. Judah was the one at fault – and he admits to – for not having given her Shelah his son to be her husband (after her first husband died).

Incidentally, the Messianic LINE came through this pregnancy! Judah almost burned the forebear to the Messianic line! And by the way, 3 months into her pregnancy, once again the statement about her fetus was "she is with CHILD..."

If, or when, YOU'VE had an abortion

Let me hasten to add, if any of you hearing this has had an abortion – yes, that was a terrible sin. But remember, dear child of God, Yeshua came and bled and died for each of us, to forgive each and every single one of us, of ALL – every single one – of ALL our sins.

1 John 1:7,9

"But if we walk in the light as He is in the light, we have fellowship with one another, and the **blood of Jesus Christ His Son cleanses us from ALL sin.**

Verse 9: If we confess our sins, He is faithful and just to forgive us our sins and to cleanse us **from ALL** unrighteousness."

So if *you* have had an abortion, for any reason, if you will sorrowfully confess that before your Maker, and repent deeply of it, your sin will be totally forgiven. I sure count on the blood of Yeshua to cleanse me of my sins - - and you can count on it too for yours. But let's be clear: my sins were *sins*. Your sins were sins. Abortion is also a sin; it must be repented of and if so – it will be forgiven. Glory to Yeshua and to our merciful Father in heaven.

I would also recommend that you do everything in your power to become a POSITIVE force in this arena – rather than just one attacking abortions and people having abortions. Why not assist, volunteer at, and even support Crisis Pregnancy Centers? At these centers, expectant young moms who are scared, penniless, often jobless – often still in high school or a city college – are given hope. These young women are often given assistance, hope, financial assistance, tangible help like blankets, baby furniture and diapers. Yes, they are shown their baby by sonograms.

These Crisis Pregnancy Centers need money to keep operating. They don't get government help – though Planned Parenthood gets 1/2 billion dollars every year via your TAX dollars, from the US Government, even while they boast that they are the #1 purveyor of abortions in the country. It makes me sick to my stomach.

So if you've had an abortion, have repented of it and want to help other young women have a better option: get out there and support in any way you can – the Crisis Pregnancy Centers all around America.

Let's segway now to another point.

Does scripture tell us when human life begins?

Scripture does not give a clear-cut answer. Some believe it must be at conception, when the male sperm unites with the female egg and start a new life. I tend to lean to this understanding of it, with the addition of saying – if it's not at conception, it probably is very soon after.

When does the heart form and start beating? NewHealthGuide.org had this to say:

“...barely a fortnight (14 days) after fertilization, the heart is forming. By the fifth week of the gestation period, the heart starts beating and divides into chambers. Six weeks later blood is flowing inside the body, and there is an improved heartbeat rate of 100 to 160 every minute. So you can **hear** a baby's heartbeat at six week gestation.”

I've heard and read that the new life has a beating heart by day 18. We can actually HEAR the beating heart of this little unborn baby by day 45 or so since conception. Sonograms have shown us clearly that certainly by 20th week – 5 months along – there is no question to those who won't deny the science – that this unborn child can move, has nerves therefore, and can feel pain. We know they can hear their mother's voice and can respond – as the future John the Baptist did in the womb.

By 8-10 weeks, they have organs working, the brain is working, the kidneys are working. There's a fingerprint. Folks, this is not just “tissue”. It's not a flea, a dog or a lizard. It's a baby boy or baby girl, unborn yet, but this is PRECIOUS, sacred, human life.

The vast majority of abortions – MOST of the 1 million a year abortions done in the western world alone each year, the majority – are done after 20-21 weeks, when the fetus, the little boy or little girl in the womb, can be kept alive! I personally witnessed a little girl who was premature at 5 or 5-1/2 months – after we prayed over her, develop into a real active, healthy child. She's in her late 20's or early 30 something today. The doctors told me not to give her young worried mom any hope... but that baby lives, and grew to be a fine and beautiful young lady today.

SO get this: the MAJORITY of abortions are done *past* the 20 week time period. And very, very few are performed because the life of the mom is in danger or because there was incest or a horrible rape. For most, the rationale is that it is far more convenient to end this innocent baby's life – than to cope with an unplanned and unwanted pregnancy. God help us! And society largely endorses this and says it's OK. God help us!

What causes life in a HUMAN?

Genesis 2:7 tells us that Adam – who was formed from the dust of the ground – became a living soul, a living being, when Yahweh blew HIS breath into the man. Up until then, he was just a pile of dust and dirt. In fact his name – Adam – is very suggestive of “dirt”! But when Yahweh Elohim blew God’s breath into him, he became a living being. So it was at that moment that Yah (God) gave him a beating heart, blood started flowing through his veins, lungs started breathing in and expelling air, his brain waves became activated – everything that imparted life for this human came from GOD’S BREATH.

Genesis 2:7

“And the Lord God (YHVH Elohim) formed man of the dust of the ground, and breathed [BLEW] into his nostrils ***the breath of life; and man became a living being***”

Note a huge difference between man and animals: man was separately created by Yahweh and Yahweh breathed into the man. Animals were commanded to appear out of the ground (Gen 1:24-25), were not hand-formed, and never had the breath of God breathed into them.

I believe God’s breath also gave the first human – Adam – something not found in animals: the “spirit in man”. You can do a concordance search on it and study it yourself. It’s a spirit essence that people have – and animals don’t have. It is what makes us human. It’s what gives us MINDS, instead of just brains and instinct.

If you wish to study into the “Spirit in mankind” more – look at these passages for starters:

1 Corinthians 2:9-11-- says we understand human knowledge by the spirit of man in us. When God gives us His HOLY Spirit, we already had a spirit that can interface with God’s special Spirit – and the HOLY Spirit gives us *spiritual* understanding.

Job 32:8

“But there is a spirit in man,
And the breath of the Almighty gives him understanding.”

It’s the spirit in man that gives us life. Without the spirit in man, we are dead. It’s sometimes referred to as “the soul” by some, but I prefer the usual term used in scripture as “the spirit of man”. When we die, that spirit goes back to God who gave it (Hebrews 12:23; Ecclesiastes 12:7; Ecclesiastes 3:21.)

We can see this clearly with these scriptures:

James 2:26

“For as **the body without the spirit is dead**, so faith without works is dead also.”

We can reverse that statement also: **the body WITH the spirit is ALIVE**. Without the spirit, it’s dead. It is the spirit in man that – in fact – gives human life. So if the Scriptures say the unborn baby is *alive*, then that baby must have the spirit in man that gives humans their life... because once again: the body without the spirit is dead (James 2:26a). So it’s clear that a pregnant woman is carrying HUMAN life from its earliest stages.

When we die, that spirit in mankind goes to God - Ecclesiastes 12:7.

Yeshua resurrected a young girl who had died. Notice what brought her back to life:

Luke 8:54-55

'But He put them all outside, took her by the hand and called, saying, "Little girl, arise." 55 **Then her SPIRIT returned, and she arose** immediately. And He commanded that she be given something to eat.'

Elijah had a similar experience when he resurrected a young lad.

1 Kings 17:19-22

And he said to her, "Give me your son." So he took him out of her arms and carried him to the upper room where he was staying, and laid him on his own bed. 20 Then he cried out to YHVH and said, "YHVH my God, have You also brought tragedy on the widow with whom I lodge, by killing her son?"

21 And he stretched himself out on the child three times, and cried out to YHVH and said, "YHVH my God, I pray, **let this child's soul come back to him.**" 22 Then YHVH heard the voice of Elijah; and **the soul of the child came back to him**, and he revived.

Why am I reading these verses?

Because human life is brought about by the presence of the "spirit in man". Without that human spirit, the body is dead (James 2:26).

We've already read that God Himself says HE forms the an unborn baby – the fetus; HE knows the unborn baby; he has a book written for plans for that unborn child – who IS alive, and we can't be alive without the spirit in man according to James 2:26.

SO, the way I see this, the unborn child has the spirit in man (not God's holy spirit), making her/him human, and when that unborn child is viciously killed (and it IS vicious), her/his spirit goes to God who gave it. All of this will figure prominently when we discuss what might happen later.

Is that the end for that unborn child? I think not. But we'll talk about that in a few more minutes.

WHAT IF THE PREGNANCY was due to a rape or violent incidence?

This of course was the premise of the Roe v. Wade Supreme Court decision – that Roe (Norma McCorvey) had been gang raped. Norma later told the truth, after the decision had long been rendered, that she had lied, and that she had become pregnant by her boyfriend.

But what about those who were in fact raped and became pregnant? I can understand the lady not wanting the reminder every time she sees the child. I understand her temptation to abort the pregnancy. I get that. It can't be easy.

But now based on everything we've already read, we have to ask:

- When do 2 wrongs make a right? The rape is evil. But what did the living unborn child do to warrant being killed – no matter what happened to his/her mom!?
- The rape was wrong, terrible and evil. But destroying a living, unborn baby is just as wrong, terrible and evil.

So what options could we have?

I think there are thousands of couples who can't have children who would love that child carried to full term and given up for adoption to a couple who would love to raise it in a home of love.

So I recommend adoption in these cases if the actual mom insists she can't live with a baby that came about due to rape or violence or incest.

What if continuing the pregnancy will endanger the life of the mother?

This one is the toughest. Nothing that was said previously is changed by this. However, I certainly would be quick to make these points crystal clear:

- I certainly will not be judging the mom in question, whatever she and her husband and doctor – hopefully with a ton of prayer too – decide.
- I would never recommend jumping automatically to the “let's abort” option. Check out all possibilities before deciding.
- God does still heal. Miracles do still happen. Call me, and I'll share a few I've seen and witnessed, even very recently.

Tim Tebow, the great football player, is a case in point, where his mom suffered a life-threatening infection during her pregnancy. The drugs they were giving her caused a serious placental abruption. But though she was being urged to end her little unborn boy's life, she persisted – and today we know that little boy growing inside her --as Tim Tebow.

My wife and I have had problem pregnancies. Our first son died after a very serious and difficult pregnancy. After that, my wife had 2 miscarriages. We know about problem pregnancies. Perhaps not life-threatening – but none of this was fun. So I pray for any of you in serious, life threatening situations.

Of course an abortion not only threatens, but ends the life of a little unborn baby girl or boy. But whatever route you take, it is between you and God. And I'm not going to judge or condemn you for your decision.

WHAT could be the aborted child's FUTURE?

What could be the aborted babies' future? My honest answer: I'm not sure anyone knows for sure. But based on what we've read and seen so far, I suspect they are going to be resurrected and will live a long life. I believe this because:

- Each fetus/baby has the spirit in man that goes to God upon death (Ecclesiastes 12:7). This spirit in man is what makes each one of them an alive human being (Gen 2:7). So they had to have the Spirit in man – and that spirit goes back to God when

they were painfully destroyed. God knows everything there is to know about each unborn child. Of course, HE designed each one. Every single one.

- Is Almighty God, who loves all creatures – especially helpless babies and unborns – is God going to let any man or woman thwart HIS plan for that being? Certainly not!
- Scripture tells us that all who ever lived will be brought back to life. So my understanding of scripture is that this has to apply even to all the aborted children.

Let's review:

Psalms 139:15-16

"My frame was not hidden from You when I was made in secret,
And skillfully wrought in the lowest parts of the earth.

16 Your eyes saw my substance, being yet unformed.

**And in Your book they all were written, The days fashioned for me,
When as yet there were none of them."**

This passage seems to indicate there were plans for this child... God can cope with interruptions in His plan, and he apparently allows us to have free moral agency and free choice, **but God's plan for each unborn will not be overruled by someone deciding to end their pregnancy!**

I believe strongly that each one will be resurrected, and will be allowed to be born and grow up to full adulthood.

Almighty has a FUTURE for every conceived child. I strongly believe that. If I'm right, I personally believe God is going to somehow resurrect them, and have them come to full term, be born – or He could just have them resurrected as they would have been at full term.

But if the way we're reading scripture is right, that GOD knows them before their birth, God has plans for them before their birth, and God formed them and gave them life, and formed them all in his image.... Do we really suppose that any man or woman could thwart God's plan for that unborn child? I don't think so!

In conclusion:

Mothers' womb is designed and intended to be the fortress of protection for the unborn child she carries inside of her. That unborn little boy or little girl should be carefully protected until birth. Abortion is ending a defenseless human life, a little unborn girl or boy. We haven't even touched on the fact that so many who have abortions end up with many health issues, psychological issues, regrets, self-condemnation and more. Others use abortion simply as a form of birth control – without regard to the human baby they killed.

God says HE knows each of them. He formed each of them. He has plans for each of them.

Pray "thy kingdom come, Lord". And do all you can to help those Crisis Pregnancy Centers in your community. DO something. Be understanding of the pain and struggle that a young woman may be going thru.
